

Does attendance really matter?

The 'Missing Child, Missing Grades' Report (November 2023) found that poor attendance has a major impact on GCSE results:

- 78% of all children who were rarely absent (above 95%) in both years 10 and 11 passed at least 5 GCSEs including Eng and maths
- Only **36**% of children who were persistently absent (below 90%) in both years 10 and 11 passed 5 GCSEs inc. Eng & maths
- Just 5% of children who were severely absent (below 50%) in both years passed 5 GCSEs including Eng & maths



Government Statutory Guidance: Leave of Absence and Penalty Notices

- "Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances".
- Holidays are not considered exceptional circumstances.
- The Local Authority can fine parents for the unauthorised absence of their child from school by issuing a penalty notice.
- Unauthorised absence can include persistent lateness to school, students missing school without a valid reason and unauthorised leave of absence
- Each parent who is liable for the student's offence(s) can be issued
 with a penalty notice, but this will usually only be the parent/parents
 who allowed the absence.
- If issued with a first penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.



Attendance- Parent/Carer expectations:



- · Make sure their child attends everyday on time
- Contact the school to report their child's absence before 8:30am on the day of the absence via telephone messages, Class Charts or email attendance@highamlaneschool.co.uk informing school of the reason for absence when they are expected to return. This must also be done on each subsequent day of absence.
- Ensure that, where possible, appointments for their child are made outside of the school day and after 4:00pm to account for if your child has an after school detention.
- Seek support, where necessary, for maintaining good attendance, by contacting your child's Progress Leader who can be contacted via contactus@highamlaneschool.co.uk
